## The Amelia Center's 15th Annual Spring Bereavement Workshop

## **Program description**

Attachment status is one of a very few factors that have consistently been identified by researchers seeking to understand the underlying causes of complicated vs. normal grief. These findings concerning adaptation to loss are part of a growing body of research emphasizing the impact of early relational experience and attachment orientation on emotional health across the lifespan. In this full day presentation, the instructor will explain the significance of contemporary perspectives on attachment that are critical to understanding variations in how people grieve and will explore in depth the implications of these insights for the practice of therapy with bereaved individuals.

Death competence, defined as specialized skill in tolerating and managing clients' problems related to dying, death, and bereavement, is a necessary prerequisite for ethical practice in grief counseling. We will discuss the evolution of this concept and consider why death competence is essential to providing clinically effective and ethically sensitive grief counseling. Throughout the day we will use client videos and case discussion to deepen our understanding of how theory translates into practice. Ample time will also be given for questions and discussion with those in attendance. You will end the day with insight into the value of attachment theory in guiding treatment formulation and with tools that will help you support your bereaved clients.

### **Learning Objectives**

At the conclusion of this workshop, participants will be able to:

- 1. Identify core principles of attachment theory that relate to grief and loss.
- 2. Define what is meant by "death competence" and discuss why death competence is essential to the ethical practice of grief therapy.
- 3. Describe recent developments in bereavement research, in neuroscience and in attachment theory that bear on our understanding of how people adapt to loss.
- 4. Describe what is meant by "attachment informed grief therapy" and discuss the practical application of attachment theory in providing bereavement support to individuals with attachment related grief complications.
